

Ordinance No. 144

AN ORDINANCE SIGNIFYING THE INTENTION OF THE BOROUGH OF FREEPORT TO ORGANIZE A MUNICIPAL AUTHORITY UNDER THE ACT OF 2 MAY 1945, P. L. 382, AND ITS AMENDMENTS, TO BE KNOWN AS "FREEPORT MUNICIPAL SEWAGE DISPOSAL AUTHORITY" FOR THE PURPOSE OF CONSTRUCTING AND OPERATING A SEWAGE DISPOSAL PLANT.

THE TOWN COUNCIL OF THE BOROUGH OF FREEPORT DOES HEREBY ORDAIN AND ENACT, AND IT IS HEREBY ORDAINED AND ENACTED BY AUTHORITY OF THE SAME.

Section 1. The Borough of Freeport hereby signifies its intention and desire to organize a sewage disposal authority under the Municipal Authorities Act approved 2 May 1945, P. L. 382, and its amendments.

Section 2. President of Council and the Borough Secretary are hereby authorized and directed to execute on behalf of the Borough of Freeport Articles of Incorporation for said Authority and substantially the following form:

ARTICLES OF INCORPORATION

TO THE SECRETARY OF THE COMMONWEALTH, COMMONWEALTH OF PENNSYLVANIA:

In compliance with the requirements of the Act of 2 May 1945, P. L. 382 as amended, the Council of the Borough of Freeport, a municipal corporation of the County of Armstrong, Commonwealth of Pennsylvania, desiring to organize an authority thereunder, does hereby certify:

- 1. The name of the Authority is "Freeport Borough Municipal Sewage Disposal Authority."
- 2. Said Authority is formed under the Act of 2 May 1945, P. L. 382 as amended.
- 3. No other authority organized under the said Act of 2 May 1945, as amended and supplemented, or by any previous Acts of Assembly, authorizing and regulating municipal authorities, is in existence in or for the incorporating municipality, the said Borough of Freeport, Armstrong County, Pennsylvania.
- 4. The name of the incorporating municipality is the Borough of Freeport, and the names and addresses of its municipal authorities are as follow
