ORDINANCE NO. 175

AN ORDINANCE APPROVING THE PETITION FOR ANNEXING TO THE BOROUGH OF FREEPORT A SECTION OF SOUTH BUFFALO TOWNSHIP, ARMSTRONG COUNTY, PENNSYLVANIA, ADJACENT TO SAID BOROUGH OF FREEPORT AND HEREINAFTER FULLY DESCRIBED AND PROVIDING THAT THE SAID TERRITORY SHALL BE ANNEXED TO AND BECOME A PART OF THE SAID BOROUGH IF THE ANNEXATION THEREOF SHALL BE APPROVED BY THE COURT OF QUARTER SESSIONS OF ARMSTRONG COUNTY.

WHEREAS, the majority of the freeholders of land in the section of South Buffalo Township, Armstrong County, Pennsylvania, adjacent to the said Borough of Freeport and hereinafter more fully described, have Petitioned the Council of the Borough of Freeport requesting the annexation of such territory; and

WHEREAS, such Petition has been accompanied by the fee of One Hundred Fifty Dollars (\$150.00) as required by law; and

WHEREAS, such Petition has attached thereto the certification of the filing of a copy thereof without the signatures with the Supervisors of the said South Buffalo Township.

NOW, THEREFORE, BE IT ENACTED BY THE TOWN COUNCIL OF THE BOROUGH OF FREEPORT AND IT IS HEREBY ENACTED BY AUTHORITY OF THE SAME.

Section 1. The Borough of Freeport hereby approves the Petition of the said majority of the freeholders of the territory proposed to be annexed to Freeport Borough, Armstrong County, Pennsylvania, being that portion of South Buffalo Township, Armstrong County, Pennsylvania, adjacent to the said Borough of Freeport, more particularly bounded and described as follows:

Beginning at a point at the northwestern corner of the present boundaries of the Borough of Freeport at Buffalo Creek and the boundary of the present land of the Freeport Brick Company; thence up said Creek by the following courses and distances: North 2° 10' East 215.0 feet to a point; thence North 11° 17' West 100.0 feet to a point; thence North 19° 15' West 220.0 feet to a point; thence North 40° 30' West 110.0 feet to a point; thence North 47° 30' West 150.0 feet to a point; thence North 45° 00' West 150.0 feet to a point; thence North 49° 25' West 930.0 feet to a point; thence North 33° 34' West 260.0 feet to a point on the line between Armstrong County and Butler County; thence by said County line North 2° 15' East 1500.0 feet to a point on Buffalo Creek; thence by said Buffalo Creek by the following courses and distances: North 40° 13' East 650.0 feet to a point; thence North 64° 42' East 161.0 feet to a point; thence South 81° 54' East 212.0 feet to a point; thence

thence North 88° 39' East 173.0 feet to a point; thence North 84° 33' East 16.0 feet to a point; thence North 88° 49' East 259.0 feet to a point; thence South 86° 14' East 344.0 feet to a point; thence North 88° 02' East 234.0 feet to a point; thence North 62° 50' East 378.0 feet to a point on line of lands of A. C. Stewart; thence by said Stewart land South 64° 00' East 325.0 feet to a point on line of lands of J. L. Patterson Heirs; thence by said Patterson land South 17° 00' West 1547.5 feet to a point; thence by same South 84° 30' East 312.0 feet to a point; thence by same South 15° 00' West 349.0 feet to a point; thence by same North 84° 30' West 312.0 feet to a point; thence by same North 15° 00' East 349.0 feet to a point; thence by same North 36° 45' West 130.0 feet to a point; thence by same South 14° 00' West 404.4 feet to a point; thence by same South 57° 24' East 847.7 feet to a point; thence by same South 8° 10' East 596.8 feet to a point on line of land of Oakridge Cemetery; thence by said Oakridge Cemetery North 83° 41' West 368.5 feet to a point; thence by same South 13° 36' East 514.2 feet to a point; thence by same South 88° 41' East 60.9 feet to a point on line of lands of St. Mary's Church; thence by said land of St. Mary's Church South 5° 36' East 300.9 feet to a point; thence by same South 28° 08' West 368.6 feet to a point; thence by same South 76° 12' East 499.9 feet to a point; thence by same South 12° 24' West 240.0 feet to a point on the present boundary line of Freeport Borough; thence by said present boundary line of Freeport Borough North 68° 15' West 2350.0 feet to a point, the place of beginning. Containing 249.0 acres as per survey of R. B. Shannon & Associates, Kittanning, Pennsylvania, dated October, 1962.

If the annexation of the said territory is approved by the Court of Quarter Sessions, the said territory shall be admitted, annexed to and added to the Borough of Freeport as a part and parcel of the said Borough, and the same shall, upon compliance with the legal requirements, be subject to the jurisdiction of the authorities of the said Borough of Freeport and shall be entitled to the privileges of the same.

Section 2. The proper officials of the Borough of Freeport, as required by law, are authorized and directed to certify to the Court of Quarter Sessions of Armstrong County, Pennsylvania, the said Petition as approved hereby and to file on the said Court a certified copy of this Ordinance, together with any maps, plots and descriptions required by law to be filed and to give proper notice of such annexation to the County Board of Elections of the said County.
