

ORDINANCE NO. 185

AN ORDINANCE APPROVING THE PETITION FOR ANNEXING TO THE BOROUGH OF FREEPORT A SECTION OF SOUTH BUFFALO TOWNSHIP, ARMSTRONG COUNTY, PENNSYLVANIA, ADJACENT TO SAID BOROUGH OF FREEPORT AND HEREINAFTER FULLY DESCRIBED AND PROVIDING THAT THE SAID TERRITORY SHALL BE ANNEXED TO AND BECOME A PART OF THE SAID BOROUGH IF THE ANNEXATION THEREOF SHALL BE APPROVED BY THE COURT OF QUARTER SESSIONS OF ARMSTRONG COUNTY.

WHEREAS, the majority of the freeholders of land in the section of South Buffalo Township, Armstrong County, Pennsylvania, adjacent to the said Borough of Freeport and hereinafter more fully described, have petitioned the Council of the Borough of Freeport requesting the annexation of such territory; and

WHEREAS, such Petition has been accompanied by the fee of One Hundred Fifty Dollars (\$150.00) as required by law; and

WHEREAS, such Petition has attached thereto the certification of the filing of a copy thereof without the signatures with the Supervisors of the said South Buffalo Township.

NOW, THEREFORE, BE IT ENACTED BY THE TOWN COUNCIL OF THE BOROUGH OF FREEPORT AND IT IS HEREBY ENACTED BY AUTHORITY OF THE SAME.

Section 1. The Borough of Freeport hereby approves the Petition of the said majority of the freeholders of the territory proposed to be annexed to Freeport Borough, Armstrong County, Pennsylvania, being that portion of South Buffalo Township, Armstrong County, Pennsylvania, adjacent to the said Borough of Freeport, more particularly bounded and described as follows:

Beginning at the north corner of the herein described tract of land on the east bank of Buffalo Creek where Freeport Borough corners on the Armstrong and Butler County Line; thence along the east bank of Buffalo Creek and Freeport Borough S 33 3/4' E 260 feet to a point; thence continuing by same S 49 25' E 930 feet to a point; thence S 45 00' E 150 feet to a point; thence by same S 47 30' E 150 feet to a point; thence by same S 40 30' E 110 feet to a point; thence by same S 19 15' E 220 feet to a point; thence by same S 11 17' E 100 feet to a point; thence by same S 2 10' W 215 feet to a point on the former South Buffalo Township - Freeport Borough line; thence N 68 15' W 60 feet to the center of Buffalo Creek; thence by the center of Buffalo Creek and Freeport Borough line S 19 50' W 320 feet to a point; thence by same S 28 27' W 2000 feet to a point; thence by same S 13 10' W 1200 feet to a point on the Armstrong - Butler County line; thence along said County line N 2 13' E 4800 feet to the place of beginning, containing 67 acres, more or less.

If the annexation of the said territory is approved by the Court of Quarter Sessions, the said territory shall be admitted, annexed to and added to the Borough of Freeport as a part and parcel of the said Borough, and the same shall, upon compliance with the legal requirements, be subject to the jurisdiction of the authorities of the said Borough of Freeport and shall be entitled to the privileges of the same.

Section 2. The proper officials of the Borough of Freeport, as required by law, are authorized and directed to certify to the Court of Quarter Sessions of Armstrong County, Pennsylvania, the said Petition as approved hereby and to file on the said Court a certified copy of this Ordinance, together with any maps, plots and descriptions required by law to be filed and to give proper notice of such annexation to the County Board of Elections of the said County.
