

ORDINANCE NO. 192

AN ORDINANCE APPROVING THE PETITION FOR ANNEXATION TO THE BOROUGH OF FREEPORT A SECTION OF SOUTH BUFFALO TOWNSHIP, ARMSTRONG COUNTY, PENNSYLVANIA, ADJACENT TO SAID BOROUGH OF FREEPORT AND HEREINAFTER FULLY DESCRIBED AND PROVIDING THAT THE SAID TERRITORY SHALL BE ANNEXED TO AND BECOME A PART OF THE SAID BOROUGH IF THE ANNEXATION THEREOF SHALL BE APPROVED BY THE COURT OF QUARTER SESSIONS OF ARMSTRONG COUNTY

WHEREAS, the majority of the freeholders of land in the section of South Buffalo Township, Armstrong County, Pennsylvania, adjacent to the said Borough of Freeport and hereinafter more fully described, have petitioned the Council of the Borough of Freeport requesting the annexation of such territory; and

WHEREAS, such Petition has been accompanied by the fee of One Hundred Fifty (\$150.00) Dollars as required by law; and

WHEREAS, such Petition has attached thereto the certification of the filing of a copy thereof without the signatures with the Supervisors of the said South Buffalo Township.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE TOWN COUNCIL OF THE BOROUGH OF FREEPORT AND IT IS HEREBY ORDAINED AND ENACTED BY AUTHORITY OF THE SAME.

Section 1. The Borough of Freeport hereby approves the Petition of the said majority of the freeholders of the territory proposed to be annexed to Freeport Borough, Armstrong County, Pennsylvania, being that portion of South Buffalo Township, Armstrong County, Pennsylvania, adjacent to the said Borough of Freeport, more particularly bounded and described as follows:

BEGINNING at a concrete monument on line of land of Oakridge Cemetery in South Buffalo Township, also being the boundary line between Freeport Borough and South Buffalo Township; thence by the present boundary line between the said Borough and Township, North 8° 10' 00" West 596.80 feet to a concrete monument; thence by same North 57° 24' 00" West 847.70 feet to a concrete monument;

thence North 14° 00' 00" East 404.43 feet to a point; thence South 86° 45' 00" East 130.00 feet to a point; thence South 15° 00' West 349.00 feet to a point; thence South 84° 30' East 312.00 feet to a point; thence North 15° 00' East 349.00 feet to a point; thence North 84° 30' West 312.00 feet to a point; thence North 17° 00' 00" East 1,610.94 feet to a point; thence North 68° 57' 20" West 418.62 feet to a point; thence on a line through South Buffalo Township being the line of land between Freeport Brick Company and Mary R. Lepper et al, by the following courses and distances: North 47° 44' 00" East 232.00 feet to a point; thence North 42° 44' 00" East 220.00 feet to a point; thence North 34° 49' 00" East 184.00 feet to a point; thence North 5° 09' 00" East 130.00 feet to a point; thence North 5° 54' 00" East 115.00 feet to a point; thence North 22° 54' 00" East 130.00 feet to a point; thence North 29° 39' 00" East 175.00 feet to a point; thence North 18° 09' 00" East 143.00 feet to a point; thence North 5° 39' 00" East 374.00 feet to a point; thence North 3° 21' 00" West 295.00 feet to a point; thence North 45° 09' 00" East 70.00 feet to a point; thence North 59° 34' 00" East 185.00 feet to a point; thence North 76° 31' 50" East 202.35 feet to a point; on line of lands of Freeport Archery Club; thence South 89° 36' 30" East 488.84 feet to a point on line of lands of Charles D. Thompson; thence by said line North 65° 10' 00" East 369.73 feet to a point; thence by same South 73° 05' 00" East 401.30 feet to a point on line of lands of Montgomery Plan of Lots; thence by said line South 24° 45' 00" West 627.36 feet to a point; thence by same South 75° 50' 00" East 409.32 feet to a point on line of lands of Lepper; thence by said line South 8° 00' 00" West 1385.77 feet to a point on line of lands of Neubert; thence by said line North 73° 47' 00" West 261.46 feet to a stone monument; thence by same South 16° 38' 00" West 278.60 feet to a point; thence by same South 76° 06' 40" East 551.87 feet to a point on the line of land of Pennsylvania traffic route no. 28; thence by said line South 2° 45' 00" West 330.86 feet to a point; thence by same on a curve to the right with radius 1,610.33 feet in a southerly direction a distance of 234.45 feet to a point on line of lands of Century Coal Company; thence by said line North 68° 57' 20" West 271.04 feet to a point; thence by same South 13° 27' 00" West 996.56 feet to a point in the center line of township road No. T586 bounding land of Emma Beale; thence by said center line by the following courses and distances: South 62° 51' 00" West 328.13 feet to a point; thence South 48° 42' 30" West 250.37 feet to a point; thence South 1° 21' 10" East 390.84 feet to a point; thence South 5° 09' 50" West 209.59 feet to a point; thence South 9° 16' 20" East 498.83 feet to a point on land of Freeport Cemetery; thence by said line North 86° 01' 00" West 990.61 feet to a concrete monument the place of beginning, containing 200.75 acres as per survey of R. B. Shannon & Associates, William E. Stennett, Registered Surveyor, dated October 1965.

Section 2. The proper officials of the Borough of Freeport, as required by law, are authorized and directed to certify to the Court of Quarter Sessions of Armstrong County, Pennsylvania, the said Petition as approved hereby and to file in the said Court a certified copy of this Ordinance, together with any maps, plots and descriptions required by law

to be filed and to give proper notice of such annexation to the County Board of Elections of the said County.
