BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the
 Council
~~XXXXX~~ FREEPORT, County of ARMSTRONG Pennsylvania:

That a tax be and the same is hereby levied on all property and occupations within the said
 municipality subject to taxation for the fiscal year 1976, as follows:

Tax rate for general purposes, the sum of	<u>23</u> mills
on each dollar of assessed valuation, or the sum of	<u> </u> cents
on each one hundred dollars of assessed valuation.	
For debt purposes, the sum of	<u> </u> mills
on each dollar of assessed valuation, or the sum of	<u> </u> cents
on each one hundred dollars of assessed valuation.	
For <u> </u> purposes, the sum of	<u> </u> mills
on each dollar of assessed valuation, or the sum of	<u> </u> cents
on each one hundred dollars of assessed valuation.	
For <u> </u> purposes, the sum of	<u> </u> mills
on each dollar of assessed valuation, or the sum of	<u> </u> cents
on each one hundred dollars of assessed valuation.
