and the Commonwealth of Pennsylvania, fixing the tax rate for the year 1982.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council
~~XXXXXXXXXXXXXXXXXXXX~~ Freeport Borough, County of Armstrong, Pennsylvania:

That a tax be and the same is hereby levied on all property and occupations within the said municipality subject to taxation for the fiscal year 1982, as follows:

Tax rate for general purposes, the sum of	<u>25</u> mills
on each dollar of assessed valuation, or the sum of	<u>2.50</u> cents
on each one hundred dollars of assessed valuation.	
For debt purposes, the sum of	<u>0</u> mills
on each dollar of assessed valuation, or the sum of	<u>0</u> cents
on each one hundred dollars of assessed valuation.	
For _____ purposes, the sum of	<u>0</u> mills
on each dollar of assessed valuation, or the sum of	<u>0</u> cents
on each one hundred dollars of assessed valuation.	
For _____ purposes, the sum of	<u>0</u> mills
on each dollar of assessed valuation, or the sum of	<u>0</u> cents
on each one hundred dollars of assessed valuation.
