

Resolution No. 2023- 1

A RESOLUTION SETTING FORTH AN UPDATED FEE SCHEDULE FOR 2022 FOR FIRE AND BUILDING CODE ENFORCEMENT AND PERMITS, AND ALL OTHER APPLICABLE FEES FOR RUNNING EMERGENCY SERVICES IN THE BOROUGH OF FREEPORT.

WHEREAS, the Freeport Borough Council through Codes and Ordinances allowed for fees to be adjusted from time to time by Resolution. The following shall be set forth as the 2023 Fee Schedule for the Borough of Freeport:




