

**FREEPORT BOROUGH**

Resolution No. 2023 #3

**A RESOLUTION OF THE COUNCIL OF FREEPORT BROUGH, COUNTY OF ARMSTRONG, COMMONWEALTH OF PENNSYLVANIA, APPROVING TRANSFER OF PENNSYLVANIA LIQUOR CONTROL BOARD LIQUOR LICENSE NO. R-8202 LID 13136 INTO FREEPORT BOROUGH, ARMSTRONG COUNTY, PA FROM NORTH BUFFALO TOWNSHIP, ARMSTRONG COUNTY, PA TO RADHE OIL CORPORATION FOR USE AT 222 BUFFALO STREET, FREEPORT, BOROUGH OF FREEPORT, ARMSTRONG COUNTY, PA 16229.**

**WHEREAS**, Act 141 of 2000 ("the Act") which amends the Commonwealth's Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of retail liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and,

**WHEREAS**, the Act requires the applicant to obtain from the receiving municipality a resolution approving the inter-municipal transfer of the license prior to an applicant's submission of an application to the Pennsylvania Liquor Control Board; and

**WHEREAS**, amendments to the Liquor Code stipulate that, prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting interested parties to state their concerns regarding the transfer of a retail liquor license into the receiving municipality; and,

**WHEREAS**, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a retail liquor license into the municipality:


**NOW THEREFORE, BE IT RESOLVED**, that RADHE Oil Corporation has requested the approval of Freeport Borough Council for the proposed transfer of Pennsylvania Liquor Control Board Retail Liquor License Number R-8202 LID 13136 to a facility to be located at 222 Buffalo Street, Freeport, PA 16229 within Freeport Borough, Pennsylvania, with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and,

**BE IT FURTHER RESOLVED**, that the Freeport Borough Council has held a public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer and, after consideration of the issues, finds that the transfer of Retail Liquor License Number R-8202 LID 13136 to a facility to be located in Freeport Borough at 222 Buffalo Street, Freeport, PA 16229 by RADHE Oil Corporation will not adversely affect the welfare, health, peace and morals of the Borough or its residents; and,


BE IT FURTHER RESOLVED, that Freeport Borough approves, by adoption of this Resolution, the proposed transfer into Freeport Borough of Retail Liquor License Number R-8202 LID 13136 to a facility to be located at 222 Buffalo Street, Freeport, PA 16229 by RADHE Oil Corporation; and,

BE IT FURTHER RESOLVED, that the said Retail Liquor License transfer is subject to approval of the Pennsylvania Liquor Control Board.
