**RESOLUTION OF THE ARMSTRONG COUNTY COMMISSIONERS
AUTHORIZING COLLECTION OF CERTAIN MUNICIPAL TAXES BY
THE COUNTY TREASURER**

WHEREAS, the County of Armstrong, Commonwealth of Pennsylvania, (“County”) is a Sixth-Class County and a political subdivision organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, pursuant to 72 P.S. § 5511.22, the tax collector of a municipality within the County (“Tax Collector”), may deputize in writing one or more deputy tax collectors, who when so deputized, shall be authorized to receive and collect any or all of the taxes in like manner and with like authority as the tax collector appointing them; and

WHEREAS, pursuant to 72 P.S. § 5511.4d, in a sixth-class county where the county treasurer has been appointed or directed by the county commissioners to bill and collect all county and county institution district taxes within a municipality under 16 P.S. § 1701.1 (b.2), the governing body of a municipality within the county may enter into an agreement providing that the treasurer shall have the duties and responsibilities of billing and collecting all taxes levied by that municipality; and

WHEREAS, the following municipalities have authorized all necessary legal documentation and request that the Commissioners appoint or direct the Treasurer to assume the duties of tax collector to bill and collect certain taxes levied within the municipality pursuant to 16 P.S. § 1701.1 (b.2) and sign a written Agreement which memorializes all terms, conditions, powers, and scope of authority for this service therein:

Freeport Borough.

NOW, THEREFORE, BE IT RESOLVED, that the Commissioners authorize the Treasurer to commence collection of municipal taxes of the above cited municipalities as requested or delegated consistent with the terms and conditions set forth herein and as set forth in the formally executed Agreements.

FURTHER BE IT RESOLVED, by the Commissioners that Treasurer is authorized to collect the following fees:

- \$20.00 for any requested tax certification; and
- \$5.00 for any requested reprinting of any tax bill.

FURTHER BE IT RESOLVED, by the Commissioners that the Chief Clerk, as the attester, is certified to declare this resolution as a true and correct adopted copy.
